ABSTRACT

Imas Maslahah: **THE CORRELATION BETWEEN THE STUDENTS' RESPONSE OF USING SHORT STORY AS MEDIA ON THEIR ABILITY IN LEARNING COMPOUND SENTENCE AT SMPN 2 JATIWANGI KABUPATEN MAJALENGKA .**

English as internasional language have four main skills that must be studied they are reading, speaking, listening and writing. writing as one of the four language skills, constitutes as a process to obtain much informations , to get meaning from printed to written materials, the aims of the research in this thesis is to find out the data of the students response using short story response as media on their ability in learning compound sentence at *SMPN 2 Jatiwangi Majalengka*, the approach of the research in writing this thesis is using a quantitative approach, the technique for collecting data used by the writer are pretest and posttest. after the data have been collected, the writer result from the test with formula product moment, interview with asks some question to the teacher, and the questionnaire with giving some question which prepared to know the result of the influence of using short story on students' ability in learning compound sentence. The conclusion of this research is the response the students using short story and the students' ability in learning compound sentence of 64.5 and 77 this means that the teaching and learning English especially in writing short story has significant in this writer's research. And the result of the computation using formula Pearson product moment also indicates that the value of 0.66 t-table has significant 5%. It means there is positive and significant response between at standard significance 5 %, $t_o > 't'_{table}$ or $10.63 > 2.04$ or 10.63 is bigger than 2.04 by significance 5 %. It means the hypothesis (H_o) is rejected and the alternative hypothesis (H_a) is accepted. At the level of standard of significance 5 % there is a positive influence between X variable (the students' using short story) and Y variable (the students' ability in learning compound sentence). It means that the data being obtained in particular form of influence are presented are numbers; consequently, they can be measured and interpreted by means of using statical analytic.

The most of Students' SMPN 2 Jatiwangi still confused by using conjunction, conjunctive adverb and semicolon. especially to write compound sentence for example :

1. The man entered the gun
2. Bank personel was not amused

To joint the two simple sentence to a compound sentence:

The man entered the gun bank personel was not amused (incorrect)

The sentence above is absolutely not true, the true is

The man entered the gun and bank personel was not amused (correct)

(Browndough 1994:220) stated that:” *a few decades ago writing teacher were concerned with the final product of writing: the essay, the report, , the story, and what the product should ‘look” like.*

Reading English short story has a function of enlarge the students' ability in structure of sentence grammatical rules Jane Willis (1981 : 142)
The short stories are the most suitable literary genre to use in English teaching due to its shortness, is supported by Collie and Slater (1991: 196) when they list four advantages of using short stories for language teachers.
