CHAPTER I

INTRODUCTION

A. The Background Of The Problem

And now, in modern era, writing is not only used as a medium of communication but it is a skill. Writing in our mind, is very important for one of

preconditions to graduate our study. Although, writing is difficult to do, many of us said that writing is as and evil in education.

Actually, writing will be easy to us if we know how to stop the writing. Stopping the writing is important in writing, because we don't know how to stop the writing, stopping the writing, in this case in the punctuation marks.

C. The Aims Of Thinking

D. The Frame Of Thinking

Writing is a skill which must be had by us not only for the students, the educators, etc. to write well, we have to know the steps of writing, way of writing, and so on.

The one way of writing is using comma as one of the punctuation marks in sentence. We use comma in sentence in order to have its meaning. The comma is used in order to make the reader in reading the text.

The point comma as punctuation marks helps us to write in writing. The term of comma splice and fused sentence (also called fault and run on sentence) refers to error in punctuation that accurately in compound (or compound-complex) sentence. (John E. Hodges, et.all, 1986:32).

Comma is important in writing, especially in scientific writing because a writer will use utterance or the sentence from the other writer.

E. The Steps Of The Research

The writer uses the steps of research as follows:

1. Data Research

a. Theoretical Data Research

To find resource, the writer has used the theoretical data resource from books and other literatures which is related with the thesis theme for the referents.

b. Empirical Data Resource

The empirical data resource are taken and obtained from the place where the research and observation were done. In this research, the writer uses the observation, interview and test technique.

2. Population and Sample

a. Population

The population is all the members of all real or hypothetical set or person, events or subject (Walter R. Brough, 1971:115). The population of this research is the second year students of *MA AL-ISLAH* Bobos, the total all 41 students.

b. Sample

Sample is the process of selecting a few (a sample) from a bigger group (the sampling population) to become the basis for estimating or predicting a fact, situation or outcome regarding the bigger group. A sample is a subgroup of the population you are interested in. (Ranjit Kumar, 1991:148).

The sample in this research is 41 students, the writer takes all students at the second year students of MA AL-ISLAH, because the sample less of 100 it means purposive sampling.

3. The Techniques of Collecting Data

a. Observation

Observation is a method in which the scientist test hypothesis by observing people as the engage in everyday activities in their natural habitats (David R. Shafferr, 1985:13).

The writer observes the real condition of the school and process of teaching and learning English, especially about English writing.

b. Interview

Interview is the medium of communication between the research and the respondent (Pamela L. Alreck, 1985:220). The writer would like to use this technique to interview to get data is needed. The interview is done to the students, the teachers, the headmaster and the staffs about everything as a source of information for her research.

The writer directly interviews the headmaster, the English teacher and the students of the school.

c. Test

Test is a set of question or exercises or other means of measuring the skill, knowledge, intelligence, capacities of attitudes or and individual or group (Victoria, 1989:56).

The writer uses test for the students about using of comma in writing.

4. The Techniques of Data Analysis

The writer use two approaches, those are: firstly, Qualitative Data Analysis, it is used to the result of data observation and interview. And secondly, Quantitative Data Analysis, to find out the quantitative data, based on the results of the test.

The writer use error analysis for analyze the students competence in understanding comma in writing.
